## Professor Vladimir Mićić, Ph.D., associate professor at Faculty of Economics, University of Kragujevac

Professor Mićić was born in the town of Užice in 1977. In Ivanjica town, he completed his primary school and Grammar School with an excellent final mark. He is married and has two children. He has been employed at the Faculty of Economics, University of Kragujevac, since 2002.

Professor Mićić graduated from the Faculty of Economics, University of Kragujevac in 2002, the title of the thesis being: "Just-in-time as a Contemporary Concept of Production and Inventories Management". He defended his M.A. thesis at the Faculty of Economics, University of Kragujevac, in 2008, the title of the thesis being "The Adaptation of the Development of the Industry and the Industrial Policy in Serbia to the European Union's Industrial Policy". He defended his doctoral dissertation at the Faculty of Economics, University of Kragujevac, in 2011, the dissertation being entitled: "The Competitiveness of the Serbian Industry as the Presumption of Its Efficient Development".

Professor Mićić was elected a teaching assistant-trainee and a teaching assistant in 2002 and 2008, respectively. In 2011, he was elected an assistant professor in the *Economics of Industry* subject, and in 2016, he became an associate professor in the *Economics of Industry* subject.
